**NOTE: ENTRY FEES MUST BE RECEIVED FOR EACH ENTRY FOR EACH EVENT! IF FEES ARE RECEIVED FOR ONLY ONE DAY, ONLY THE FIRST EVENT WILL BE PROCESSED.**

ENTRY FEE is \$28.00 for the first entry of each dog for each event, except in Puppy class which is \$23.00 for each event. Each Additional Entry of the same dog is \$21.00 for each event. JUNIOR SHOWMANSHIP is \$10.00 for each event if entered for 'Junior Showmanship Only' or if an Additional Entry for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes. (There is no recording fee or event service fee for junior showmanship, sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.) When a dog is entered in more than one class, the highest priced class is considered the first entry.

**ENTRIES CLOSE** at Superintendent's Office, **WEDNESDAY NOON (EDT), JULY 11, 2018**, after which time entries will not be accepted, cancelled, altered or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

**DIRECTIONS TO ELKHORN VETERINARY CLINIC:** Leaving the fairgrounds through the main gate (Hwy 11) turn right (south) to Court St. and make a right turn (west). Proceed to Lincoln St. (Hwy 67) and turn left (south) all the way to O'Connor Drive. The address is 25 E. O'Connor which is a left hand turn from Lincoln St. (Maps available at the superintendent's table and at the Main gate.)

**• NOTE •**

In order to comply with the provisions of Wisconsin Statutes [s. 95.21 (2)] and Administrative Codes [s. ATCP 11.52], relating to the Statewide Rabies Control Program, the owner of any dog kept or exhibited in Wisconsin (other than a dog kept for educational or scientific purposes) shall have the dog vaccinated against rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination.

Any person (including out-of-state exhibitors) who imports a dog into Wisconsin (for exhibition or any other purpose) must have a valid interstate health certificate or certificate of veterinary inspection for that dog, regardless of the age of the dog. The certificate must be completed by a veterinarian; accompany the dog when it enters this state; and indicate the current vaccination status of the dog.

Vaccinations shall be administered by a veterinarian and comply with age and time standards and label instructions approved by the federal bureau for the type of vaccine used.

**GROUND RULES**

- The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control & restraint over their children at all times.
- Exhibitors, children & dogs are not allowed in the stable area, the Grandstand seating area or the area immediately surrounding & on or in the infield of horse trotting track.
- All "Handicap," "No Parking" & "Restricted" Parking signs as posted on the grounds, in the premium list or judging schedule must be observed. Violators will be ticketed.
- The reserved "Handicap" parking along the west street of the Fairgrounds is for "nose-in" "day parking" only. No motorhomes, no exercise pens & no grooming will be permitted in this area. Violators will be ticketed.
- All traffic around the rings & unloading area will be controlled by security personnel.
- Barricades may not be moved.
- Please keep your parking and/or grooming area clean & neat.
- No practicing is allowed in the rings at any time.
- No dogs are permitted in the showers or lavatories. There is no space for unentered dogs.

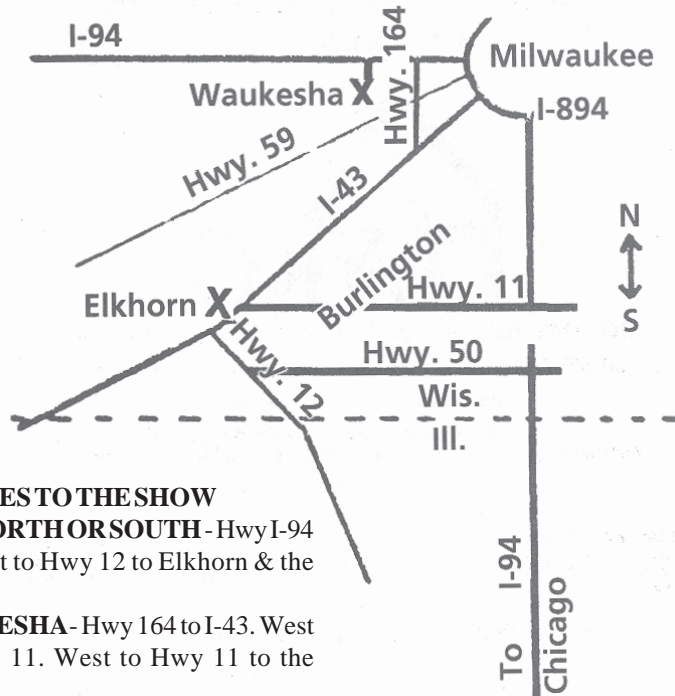
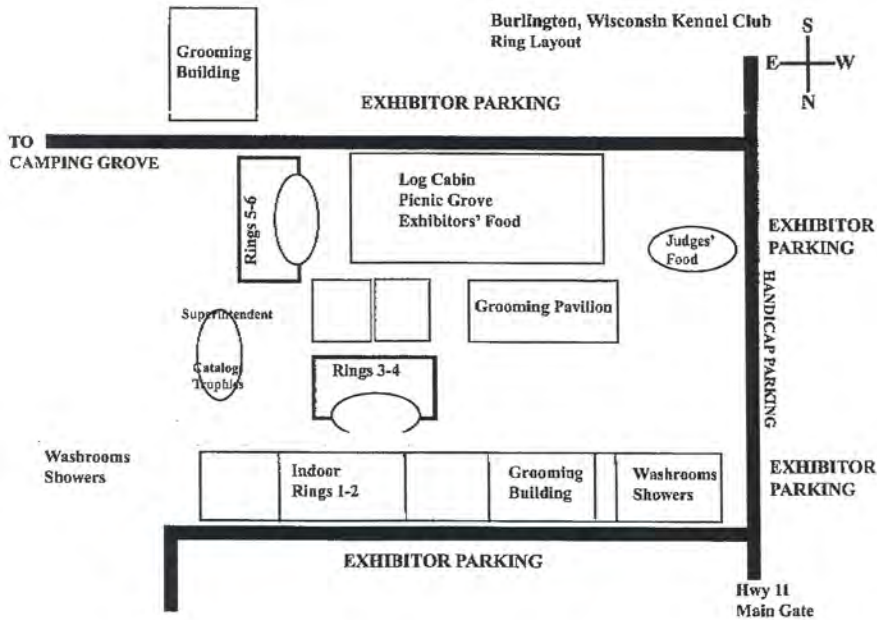

The purpose of the AKC National Owner Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.

- There is no additional fee to enter this competition.
- Entries must be marked as eligible to compete in the AKC NOHS prior to the closing of entries for that show.
- Dogs declared eligible must be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog. The Owner Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

# AKC Code of Sportsmanship

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

Lagotti Romagnoli, American Water Spaniels, Boykin Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Sussex Spaniels\*, Welsh Springer Spaniels, Basset Hounds\*, Ciriachi dell'Etna, Whippets, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Bulldogs\*, Chinese Shar-Pei\*, Chow Chows\*, Finish Spitz, Keeshonden, Norwegian Buhunds, Entlebucher Mountain Dog, Finnish Lapphunds, Polish Lowland Sheepdogs, Spanish Water Dogs & Norrbottenspets (misc).

\*By Board approved policy Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei & Chow Chows must be judged on the ramp in all conformation competition associated with AKC conformation dog shows or at which AKC conformation titles may be earned.

**A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Event Secretary prior to judging. AKC approval is not required. This policy extends to Junior Showmanship, the 4-6 Month**

**Beginner Puppy Competition, the AKC National Owner Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. The list of Table and Ramp breeds can be found on the AKC Website under Conformation Judges – Announcements.** Emergencies In emergency situations, with the approval of the Show Chair, breeds customarily examined on the ground may be examined on a ramp, not on a table.

An emergency is defined as a temporary condition that arose immediately prior to or at a dog show. Convalescence from a medical procedure, illness and recuperation from injuries are examples of conditions that are not emergencies.

The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

*(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund).*

(Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
