ENTRY FEE is \$30.00 for the first entry of each dog for each event except for Puppy Classes which are \$20.00 for each event. Each Additional Entry of the same dog is \$10.00 for each event. JUNIOR SHOWMANSHIP is \$30.00 for each event if entered for 'Junior Showmanship Only' or \$10.00 if an Additional Entry for each event. Four-To-Six Month Beginner Puppy is \$20.00 for each dog for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, or the \$2.00 AKC Event Service Fee on each entry in Four-To-Six Month Beginner Puppy. (There is no recording fee or event service fee for junior showmanship, sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.)

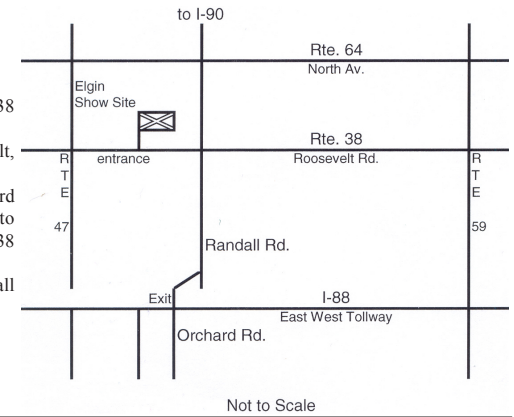

## **Elgin Kennel Club** **RV Parking Reservation Form**

**Reservations Must be Made by Entry Closing**

Our show site has 39 Hook-ups for RV's with both Water and Electric. Spaces will be assigned. Reservations must be received by closing of entries August 8, 2018. Any reservations received after the spaces have been sold out will be returned. There is a Dump Station on the east side of the RV Parking Area. **Payment in full must be received by the closing Date.** The show site will be made available to RV's beginning at **12:00 P.M. on Friday, August 24, 2018.** The cost per night will be \$45.00 for reserved parking. You will be escorted to your parking space. Do NOT proceed to a RV Parking Space without being escorted. No Reservations will be refunded after show entries closing date. The rates for dry or 20 Amp parking will be \$30.00 per night.

**GATES WILL BE LOCKED AT MIDNIGHT EACH EVENING & OPENED AT 6 A.M.** The size of each Stall is 16' by 40'. Your vehicle and ex-pens must fit within the parking space provided. If you have a car that is being towed, it must fit inside your space or must be parked in the parking area on the North side of the Building opposite of the RV Parking area. **THERE IS TO BE NO RV PARKING ON THE BLACKTOP ON THE NORTH SIDE OF THE SHOW BUILDING OR IN THE RV PARKING AREA OUTSIDE OF A DESIGNATED SPACE.**

**FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION**

**SATURDAY, AUGUST 25, 2018**

The Four-to-Six Month Beginner Puppy competition shall be for dogs that are four months of age and under six months on the day of the event. Classes will not be divided by sex in this competition. Classes will be offered for Breeds & Varieties and divided into Groups as described in Chapter 3, Section 1 of *Rules Applying to Dog Shows* and the Miscellaneous Class Breeds as listed in Chapter 3, Section 23. The Miscellaneous Class competition will be equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS Competition will be the equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A Foreign born dog may enter this class if they are registered in the country of origin.
- FSS Number of FSS Registered litter number will be required for Miscellaneous and FSS Breed Entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*
- Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs.
- Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld.
- Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-6 Month Beginner Puppy classes.
- Dogs must be excused for attacking a person or other dogs.
- No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed. Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

The purpose of the AKC National Owner Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.

- There is no additional fee to enter this competition.

- Dogs declared eligible must be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
