ENTRY FEE is \$27.00 for the first entry of each dog for each event except Puppy & Bred By Exhibitor Classes which are \$22.00 for each event. Each additional entry of the same dog is \$20.00 for each event. Veteran Class is \$22.00 for each event. JUNIOR SHOWMANSHIP is \$5.00 for each event if entered for 'Junior Showmanship Only' or as an additional entry for each event. Sweepstakes Entry Fee for Saturday is \$15.00. Sweepstakes Entry Fee for Sunday is \$10.00. First Rally Entry is \$27.00 for each event. Each additional Rally Entry of the same dog will be \$20.00 for each event. Fees include the 50¢ AKC Recording Fee and the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, or the \$3.50 AKC Recording Fee on each entry of a dog in Rally and a \$3.00 for each additional entry of the same dog. Entries shall be made at the same time and on the same form as the Regular Classes, indicating in the space for "Additional Classes" your entry in the Sweepstakes and age division.

\*By Board approved policy Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei & Chow Chows must be judged on the ramp in all conformation competition associated with AKC conformation dog shows or at which AKC conformation titles may be earned.

The emergency use of a ramp may be allowed on a day and may be extended to include a cluster as well as judging either a group and/or Best In Show.

*(In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)*

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2.
