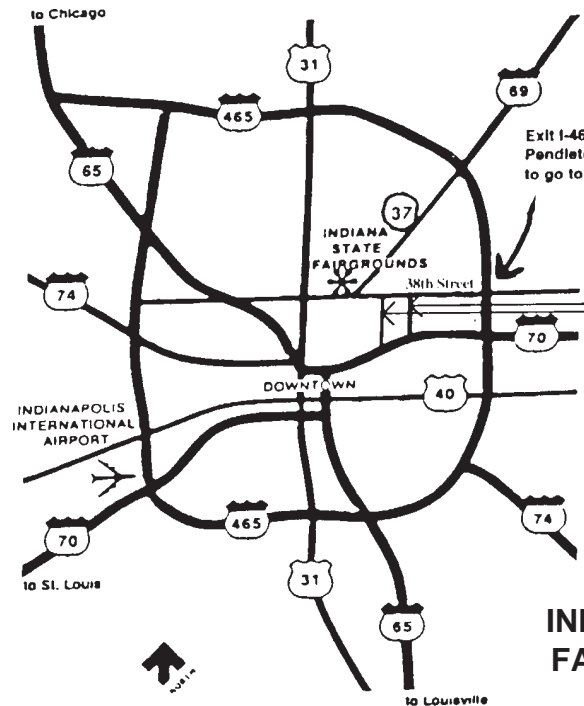

- * Vehicles will enter fairgrounds through GATE 6 off of Fall Creek Parkway or Main Gate.
 - * Vehicle headlights WILL be left on during unloading.
 - * Unloading will be on the South side of building. Traffic guards will direct you to unloading spot.
 - * Please allow extra time to unload and park at these shows. The State Fairgrounds has other events scheduled on these grounds and traffic patterns could take longer to park.
 - * Upon unloading, vehicles may be parked in area just West of unloading area.
 - * Vehicles left in unloading area more than 30 min. with no activity will be ticketed or towed without further announcement. NOTE: Towing charges are approximately \$100.00.
 - * **NO MOTOR HOMES OR ENCLOSED TRUCKS TO BE PARKED WITHIN 1000' OF ANY OCCUPIED BUILDINGS ON THE INDIANA STATE FAIRGROUNDS, BY ORDER OF THE SUPT., OF THE INDIANA STATE FAIR BOARD.**
 - * Handicap car and RV parking will be marked. Cars without proper permits to park in this area will be ticketed and towed without notice. NO SPACE FOR RV's IN HANDICAP AREA.
 - * NO SPACE FOR PRIVATE EX-PENS IN GROOMING AREA. **No exercise pens are to be set up inside the grooming area between 7:00 am and the time Variety Groups start. Ex-Pens may be set up once Group judging starts. Fire Marshal Requirement!**
 - * **NO crates will be allowed at ringside any time.**
 - * All crates MUST BE STACKED when designated by the Show Chairperson.

The purpose of the AKC National Owner Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.

- There is no additional fee to enter this competition.
- Entries must be marked as eligible to compete in the AKC NOHS prior to the closing of entries for that show.
- The handler must be an owner of record according to the AKC's records as of the date of the show.
 - Professional handler, household members and current assistants to professional handlers in conformation are not eligible to exhibit in this competition. A current assistant is defined as anyone employed by a professional handler on a full time basis, or assisting a professional handler at the show or any show during the cluster/weekend.
 - Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
 - Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner Handled Series competition (Group and Best in Show). Any person may exhibit the dog in the regular Group and Best in Show competitions.
 - Eligibility restrictions apply to all members of the same household.
- Dogs declared eligible must be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog. The Owner Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non regular classes. This excludes all dogs defeated during class and winners competition for the regular show.
 - If the Best of Breed/Variety winner of the regular show is eligible for the AKC National Owner Handled Series competition, it will also be awarded Owner Handled Best of Breed. In this case, the dog will be eligible to compete in group competition for the regular show and group competition for the AKC National Owner Handled Series.
 - If the regular show Best of Breed/Variety winner is not eligible for AKC National Owner Handled Series competition and the regular show Best of Opposite Sex to Best of Breed/Variety is eligible, the regular show Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner Handled Best of Breed.
 - If neither the Best of Breed/Variety nor the Best of Opposite Sex to Best of Breed/Variety from the regular show is eligible for the AKC National Owner Handled Series competition and both the Select Dog and Select Bitch are eligible, the judge is to choose Owner Handled Best of Breed from the Selects and any eligible Winners Dog or Winners Bitch.
 - If one of the Selects from the regular show is eligible for AKC National Owner Handled Series competition, excuse all eligible champions and non regular class winners of the same sex and then choose Owner Handled Best of Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
 - If the regular show Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog that competed in Best of Breed including Winners Dog or Winners Bitch as the Owner Handled Best of Breed.
 - If no dog remaining in the ring is eligible for the AKC National Owner Handled Series competition, Owner Handled Best of Breed will not be awarded and the Breed/Variety will not be represented in group competition for the AKC National Owner Handled Series.

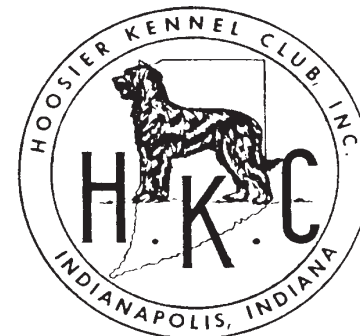

A RECORDING FEE of 50¢, and a \$3.00 AKC Event Service Fee will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in the show, a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes will be collected. 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
