**VETERAN BITCH CLASS**

7 Years &amp; Older

For Dogs and Bitches who on the day of the Show are 7 years old or over. Spayed bitches and neutered dogs are eligible in Veteran classes only. Winners may compete for Best of Breed competition if otherwise undefeated on the day of the show.

**Note:** "Neutered dogs & Spayed bitches may compete in the Veterans Classes only at Independent Specialties and/or those All-Breed Shows which do not offer any Competition beyond Best of Breed." AKC Rules Applying to Dog Shows, Chapter 11, Section 8.

**WORKING DOG CLASS****WORKING BITCH CLASS**

Classes for dogs/bitches holding NCA Working Title(s) (Draft Dog, DD; Water Dog, WD; Water Rescue Dog, WRD; Team Draft Dog, TDD) and MAY NOT be Spayed or Neutered. Winners may compete for Best of Breed competition if otherwise undefeated on the day of the show.

**BEST OF BREED COMPETITION****AWARDS OF MERIT**

Awards of Merit may be given at the Judge's discretion, irrespective of the sex of the dogs entered. The Award of Merit shall be offered based on the number of dogs competing for Best of Breed. The number of awards are determined by the size of the entry of the Best of Breed Class: 7-10 entries-up to 1 Award of Merit, 11-16 entries-up to 2 Awards of Merit, 17-23 entries-up to 3 Awards of Merit, 24-30 entries-up to 4 Awards of Merit, 31-36 entries-up to 5 Awards of Merit, 37 or more entries-up to 6 Awards of Merit. Winners will receive a Rosette.

**NON-REGULAR CLASSES INVOLVING MULTIPLE ENTRIES**

\*NOTE: Because the judge's decision in the Stud Dog, Brood Bitch & Brace Classes will be based on the Merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won this class.

**STUD DOG CLASS**-For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in any Regular Classes, or if a Champion of Record, in the Best of Breed Competition, but **MUST BE** entered in the Stud Dog Class. The Get **MUST BE** entered in one of the regular classes. The Stud Dog is considered as one entry & requires one entry fee. The Stud Dog must be shown in the ring with the Get. The Class will be judged on the Merits of the Get.  
**BROOD BITCH CLASS**-Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**BRACE CLASS**-Effective January 1, 2005. A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising a Brace **MUST** be named at the time of entry. If a dog which is to be part of a Brace is not entered in another class it must be entered for "Brace Class Only". In making entries for "Brace Class Only" full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace **MUST** be marked accordingly in the space provided for Additional Classes "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising EACH Brace unit must be so designated "Brace No. 1", "Brace No. 2", etc. PLEASE SUBMIT BRACE ENTRIES TOGETHER.

**NOVICE JUNIOR CLASS-**For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

**NOVICE INTERMEDIATE CLASS-**For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

**NOVICE SENIOR CLASS-**For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

**OPEN JUNIOR CLASS-**For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**OPEN INTERMEDIATE CLASS-**For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**OPEN SENIOR CLASS-**For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**MASTER CLASS-**This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition from the Open Class. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors Meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.
